## Guidelines for Authors

### Aims and Scope

The journals of the Geological Survey of Austria publish original scientific contributions covering the full spectrum of Earth science topics but must have a clear reference to Austria. This can be:

- by Austrian authors.
- on Austrian topics.
- topics in the border area or with close relation to Austrian earth science.
- on samples and collections material from Austria.

Contributions will **not** be subjected to peer-review. Control to ensure that the required standard of scientific excellence is maintained will be done by the editor who can decide to let a contributed article be reviewed.

Authors agree, that their articles will be offered for free at the website of the Geological Survey of Austria following the ideas of Open Access. Thus the authors are responsible, that text, figures, photos etc. are free and will not treat with any rights of third persons or institutions. All claims regarding copyrights have to be treated by the authors.

### Submission of manuscripts

Manuscripts are accepted in German or in good English (USA and UK spelling will be accepted). Authors are requested to have their manuscripts read by a person fluent in German or English before submission. The text and figure captions should be sent preferably as Word documents, tables as Word or Excel documents and figures and plates should be sent separately. Data should be sent via E-Mail or any online File Transfer Service (file hosting service, ftp clients, cloud service...) to the editor.

Authors who wish to submit a manuscript in hard copy, rather than electronically, should contact the editor first. Submission of an article is understood to imply that the article is original and unpublished and is not being considered for publication elsewhere.

#### Proof

After acceptance of the manuscript, the corresponding author (the author who submitted the manuscript to the editor) will receive a proof (pdf-files), which must be sent back to the editor within two weeks. Major changes are impossible at this stage. Delayed return of the proofs may result in postponement to a later volume.

## Preparation of the text

The manuscript should preferably be submitted in a MS-Word compatible format (i.e. docx, doc, rtf). Illustrations like text-figures and plates should be submitted separately in appropriate quality and file formats (i.e. pdf or eps for vector graphics; tiff or png for photographs and bitmapped line drawings) and named as in the manuscript (i.e. Text-Fig1.tif, Text-Fig2.bmp, Plate1.pdf...). Title and abstract in German and English have to be included independent on the language of the manuscript. The title page should include the name(s) of the author(s), their affiliations and E-Mail addresses.

### Structure and Formatting:

The manuscript should be structured in the following way:

Title (in English and German), Authors information, Keywords, Abstract (in English and German), Introduction, Main Text Body, Conclusions, Acknowledgements, References, Figure Captions, Plate Captions.

Formatting is limited to the usage of **bold** (headings), *italics* (species and genus in taxonomy) and SMALL CAPITAL (authors' names in references and citations) fonts. Headings should have a clear hierarchy of up to a maximum of 3–4 levels. Metric system has to be used for dimensions and abbreviations have to be explained.

### Keywords

The authors are requested to supply 4–6 keywords that can be used for indexing/abstracting purposes.

### Abstract

Abstract in English and German should not have more than 500 words for each language.

### Footnotes

Should be avoided or used sparingly if necessary with consecutive numbering throughout the article.

### References

All references cited in the text need to be given in the reference list and vice-versa. Citations to material “in preparation” or “submitted” are not accepted. Articles published „online first“ are accepted with provided DOI. The reference list at the end of the manuscript should be in alphabetical order except those with more than 2 authors which should be ordered by chronology (oldest on top). If DOI is available for a reference you should add it at the end of the reference (Style: <http://dx.doi.org/prefix/suffix>).

The last two authors (for publications with two or more authors) should be separated by an ampersand (&). Don't use a space between initials of authors. No italics for journal names. Use “en dash” (–), not hyphen, between page numbers. Hyphens are only accepted if they are part of the title of a publication or between initials of authors (e.g. KRENMAYR, H.-G.). Journal titles must be given in full. Journal volumes should be **bold**. Issue numbers are optional and may follow after a forward slash (/).

If title and journal of a publication cited is in a non-Latin letters language (e.g. Kyrillic, Chinese etc.) provide the transcription or English translation. Name original language in brackets at the end of the reference (e.g. (in Russian)).

## Citing

References in the text should consist of the surname of the author(s), followed by the year of publication in parentheses. Multiple citations in the text should be chronological and separated by semicolons like in the following example (GÜMBEL, 1862; PILLER et al., 2004; LEUPRECHT & MOSHAMMER, 2006;...) or “according to PILLER et al. (2004)”. Two authors should be linked by an ampersand (&), more than two authors should be cited with the first author's surname, followed by “et al.”. Citing of specific content of a publication (special page, figure, plate, table) should be linked with a colon (:) in the following way. (PILLER et al., 2004: 13) or PILLER et al., 2004: Fig. 1). Use lower case for references in other papers (e.g. „PILLER et al., 2004: Fig. 1“) and upper case for references in your own paper (e.g. „see Text-Fig. 1).

## Tables

Tables should be compiled on separate sheets in Word or Excel format and should be numbered according to their sequence in the text.

## Illustrations

Plates and Text-Figures can have a size up to 175 x 250 mm and should be numbered in the order that they are referred (cited) to in the text. Figures should be submitted at the size preferred for printing. Note that lettering in the final illustrations should be between 6 and 12 points and the minimum line thickness used should be 0.5 pt. Colour illustrations are possible without costs for the authors; they should inform the editors on submission of the text. Please make sure that map illustrations contain coordinates and pictures have a scale or scale bar (specimens). Background of plates and text-figures should be either white or black and without scanning or compression artefacts. Best use 600 dpi (minimum: 300 dpi) resolution and greyscale or CMYK as colour mode for photographs. For bitmapped line drawings use a minimum of 1,000 dpi resolution. For line drawings and vector graphics embed the font or save the text as graphics. Preferred fonts for artwork are Helvetica or Arial.

## Video and Audio

Audio and video material and animations concerning scientific research are possible and will be included in the pdf file. Authors who have video or animation files that they wish to submit with their article should contact the editor in advance. An example is shown in the following publication. Reprints will not be supplied but 1–2 copies of the complete publication (i.e. Jahrbuch issue) can be provided to the authors if necessary.
