## Information about the data policy rights after Article 13, GDPR\*

## General information

The Geological Survey of Austria (GSA) attaches great importance to the protection of your personal data. We only collect and process your personal data in compliance with the provisions of the EU General Data Protection Regulation ("GDPR") and other provisions of European and applicable national data protection law.

Therefore, we only collect and use personal data of you provided that this is necessary to organise the GELMON 2020 workshop (GDPR Art. 6.1(b)), promote the following next three GELMON workshops (GDPR Art. 6.1(f)), and to fulfil legal requirements (GDPR Art. 6.1(c)).

The personal data will be deleted after fulfilling enclosed legal requirements. Personal data (Name, Organisation, Address, e-mail) needed for informing you about the next two GELMON workshops will be deleted after seven years.

## Due to the GDPR you have the following rights:

The Geological Survey of Austria would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request the GSA for copies of your personal data. We may charge you a small fee for this service.

*The right to rectification* – You have the right to request that the GSA correct any information you believe is inaccurate. You also have the right to request the GSA to complete the information you believe is incomplete.

The right to erasure – You have the right to request that the GSA erase your personal data, under certain conditions. The right to restrict processing – You have the right to request that the GSA restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to the GSA's processing of your personal data, under certain conditions.

*The right to data portability* – You have the right to request that the GSA transfers the data, that GSA has collected, to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact our data protection officer :
